## Post Training Progressions for BJAA Analytic Members - Criteria and Processes

It is expected that BJAA members will be well placed to make the following progressions. The processes described will aim to help the individual prepare for each progression and to outline the learning that they think will be of most help to them. The BJAA will attempt to provide learning opportunities which support these progressions.

Executive and training committees convene a group to review applications. Process finalised at agreed dates, twice a year.

### Approved Therapists Requirements and Approval Route for BJAA members

- Completion of application form
- BPC qualified, automatic access for BJAA analytic members
- 3 years post bjaa qualification
- Evidence via form of 15+ hours per week clinical work or equivalent
- Reference from colleague/supervisor/peer supervisor
- Mentor conversation if wanted

# Approved Supervisors Requirements and Approval Route for BJAA members who can then be employed to offer group supervision on once weekly training

- Completion of application form
- BPC qualified, automatic access for BJAA analytic members
- 1 year after becoming Approved Therapist and 4 years post bjaa qualification
- Evidence via form of 15+ hours per week clinical work or equivalent
- Evidence of supervision experience or training (including new BJAA supervision workshops)
- Reference from colleague/supervisor/peer supervisor
- Mentor conversation if wanted

#### **Training Analysts**

4 years post-qualification as BJAA analyst

- Supervision on post training intensive work | ANALYTIC
- Reference from supervisor or peer supervisor SSOCIATION
- Groups will offer space for reflection on TA role
- 2 intensive patients seen since training, ideally not to include training patients
- Option of mentor meeting to discuss how best they might be supported by overall, London, NW2 4HJ focus on learning needed. +44(0)20 8452 9823
- Executive and training committees convene a group to review applications w.bjaa-jungiananalysis.org.uk
- Possible 2 person interview where there are uncertainties
- Clear appeal process

#### **Training Supervisors**

- Application form, plus interview with supervision case material
- Eligible I year after becoming TA
- 2 or more intensive patients seen since training, not including training patients
- Experience of offering supervision of intensive work, including within peer supervision or workshops
- Supervision workshops, training, or peer groups with supervision work presented
- Possible placements for supervision experience
- Remote supervision work would be acceptable
- Some supervision of supervision, with reference from supervisor
- Option of mentor meeting to discuss supervision work and support needed to play role and continue development

#### **Applications from Analysts from other BPC Jungian Trainings**

Application form and meets requirements as outlined for BJAA members, plus:

- Reference
- Welcome conversation if needed
- Case by case approval
- Applicants from members of other non-BPC bodies e.g. IAAP could either be accepted, subject to application process, for a single case, or go through BPF Equivalency Committee to become BPF members
